Renter Liability - Third Party: Expense related to required liability coverage through a third-party provider. Varies Per unit / month **Required**

Add Ons / Supplemental

The below costs are supplemental or needs based.

Amenity / Clubhouse Rental Deposit (Refundable): Refundable deposit for potential damages during a clubhouse rental. \$250.00 Per occurrence Optional

Amenity / Clubhouse Rental Fee: Fee for reserving the community clubhouse for events or gatherings. \$250.00 Per hour / occurrence Optional

Carport (Parking Rent): Fee for covered parking in a designated carport space. \$45.00 Per vehicle / month Optional

Reserved (Parking Rent): Fee for a designated parking spot on site. \$75.00 Per vehicle / month Optional

Pet Fee (Non-refundable): Fee for allowing pets in the home. \$500.00 Per pet / one-time Optional

Pet Rent: Monthly charge for keeping a pet in the home. \$25.00 Per pet / month Optional

Pet Screening Fee: Fee paid to PetScreening for pet profile management (*Fee waived for assistance animals*). \$30.00 Per pet / year Optional

Storage Rent: Fee for an on-site storage unit. \$75.00 Per Storage / month Optional

Situational Fees

The below costs are situationally based.

Access Card Fee Replacement: Charge to replace lost or damaged key, fob, remote, or lost parking permit. \$100.00 Per occurrence Situational

Concession Repayment: Tenant repayment of rent discounts if lease terms are not met. Varies Per occurrence Situational

Early Lease Termination Fee: Fee for ending lease agreement before its scheduled end date. 2 Months' Rent Per occurrence Situational

Improper Notice Fee: Charge for not providing proper advance notice before move-out. Varies Per occurrence Situational

Transfer Unit Fee: Charge for transferring to another home within the same community. \$700.00 Per occurrence Situational

Late Fee: Penalty for rent or fee payments made after the due date. 10% of Rent Amount Per occurrence Situational

Security Deposit Additional (Refundable): Extra refundable deposit for added risk, damages, or lease conditions.	\$200/ \$250/ \$350	Per unit / one-time	Situational
Smoking Violation Fee: For non-compliance with community smoking policy.	Up to \$500	Per occurrence	Situational
Trash Container Replacement: Charge for replacing a lost, stolen, or damaged trash bin.	\$50.00	Per occurrence	Situational
Trash Violation Fee: Charge for non-compliance of community trash policy.	\$50.00	Per occurrence	Situational
